

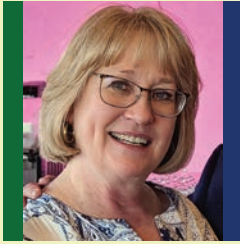

Dear Friends—

Wow – what a year 2020 has been! It's been great! (Although I'm sure some folks might disagree.) The Montgomery County Community Foundation had a very successful year.

MCCF increased our Fund Corpus to almost \$9,000,000 thanks to our own very generous Henry Brooks and his very thoughtful legacy gift, along with many other kind donors.

We provided almost \$20,000 in scholarships to deserving students throughout Montgomery County.

The Foundation awarded grants totaling over \$185,000 to local deserving non-profit entities. These charitable organizations spread their reach throughout Montgomery County in various ways, touching so many worthy folks. Do you have a favorite 501(c)3 charitable organization? Encourage it to apply. It could be a recipient of some of these funds as well.

We continue to offer our Field of Interest funds. These were created to benefit our donors by allowing a donation in memory of a loved one, or to honor a special friend, or for any reason at all. You can donate to these any time for any reason, or create your own. Pick the field that touches your heart. And most recently, MCCF distributed over \$50,000 to the Community Assistance Center and Montgomery County Food Bank for deserving families who were adversely affected by our February snow-mageddon event.

And that's while we were in the midst of a worldwide pandemic. The Foundation's President and CEO, Julie Martineau, redirected our fundraising efforts to a new format for our Annual Shoot Out rather than cancelling the event. Shooters were given the opportunity to safely set their own team's schedule over a period of several weeks and report their scores back to MCCF. We successfully raised over \$40,000 dedicated to pay office administrative costs for the Foundation. And the Shooters had a great time and stayed healthy.

Our 2020 Annual Wine Dinner raised over \$100,000 to go toward administrative costs just days before the pandemic affected the world. These two fundraisers allow us to continue to pay office administrative costs outside our funds, rather than charging the donor funds for those expenses.

Many thanks to those who continue to support the Montgomery County Community Foundation – the donors, the participants in the fundraisers, the staff, and the dedicated volunteers. MCCF is looking forward to another successful year in 2021. The world is changing. Let's be a positive part of the change!

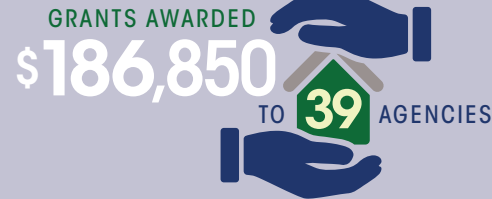

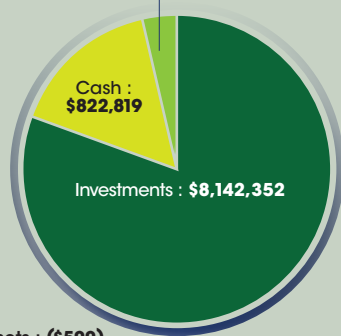

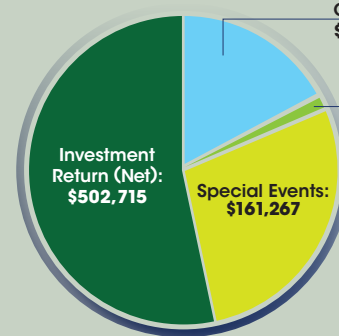

STATEMENT OF REVENUES, EXPENSE AND OTHER CHANGES IN NET ASSETS

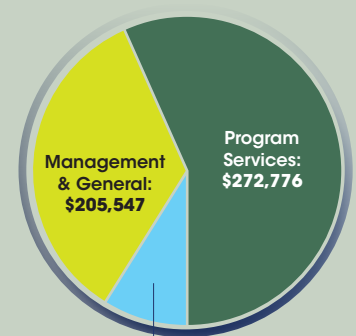

Donor Advised Funds

The **Rick and Rosalind Dauzat Endowment** focuses on grants to support the arts and culture, education, and human services. Grants from this fund will be available in 2021.

The **George and Emily Fath Fund for Human Needs** provides financial assistance to the neediest in Montgomery County. Special consideration is given to people who have sudden unexpected needs due to sickness, injury, disability, death in the family, or natural disasters. The spirit of Mathew 25:31-46 will serve as a guide.

The **Annie and Irvin Hoffman Memorial Fund** provides grants to nonprofit organizations in Montgomery County with a special interest in programs for the elderly and children.

The **Margaret and Foster Madeley Family Fund** provides funding to help create and foster secure environments and programs to enable people to experience their potential to thrive.

The **Dan H. and Martha Foster Madeley Heritage Fund** provides grants to nonprofit agencies for researching, collecting, preserving and sharing the histories of Montgomery County residents.

The **Arts and Culture Fund** supports the performing and visual arts and culture in Montgomery County.

The **Environment Preservation and Sustainability Fund** supports the environment and ecology initiatives.

The **Fostering Hope for Abused and Neglected Children Fund** honors past MCCF executive director Shannon Kidd; her passion is helping abused and neglected children.

The **Health and Wellness Fund** supports physical and mental care needs including prevention and education.

The **Dr. Jeffrey Kass, MD Elderly Assistance Fund** will support the indigent elderly in need by offering nutrition, medical care, medications, transportation assistance and companionship.

The **Dr. Jeffrey Kass, MD Dog Rescue and Animal Welfare Fund** ensures services such as fostering, veterinarian care, transportation and adoption are available to dog rescue groups and those caring for injured, abandoned, or abused animals.

The **Long Term Disaster Recovery Fund** helps residents recover from disaster in Montgomery County.

The **Montgomery County Adult Literacy Fund** furthers adult literacy in Montgomery County.

The **Elsie Mae and Edward Everett Taylor Fund** was created to provide financial assistance to the neediest citizens in Montgomery County with a special interest in the elderly.

The **Veterans Fund** is designed to support services, programs and initiatives for veterans.

The **Woodlands Medical Center Foundation Fund** supports "health care and wellness assistance and education, including shelter and medical or psychological screening, treatment, or counseling in South Montgomery County/The Woodlands area. Funding for capital improvements for buildings, improvements, furnishings, or equipment and/or related program expenses."

The **Vernon Randolph Yeakley Animal Welfare Fund** offers grants to promote the humane treatment of animals through community education and supporting responsible pet/animal ownership.

Scholarship Program

The **Henry and Billie Brooks Scholarship at Lone Star College-Montgomery** provides need-based scholarships to citizens of the United States of America, who are residents of Montgomery County and wish to attend Lone Star College-Montgomery. In 2020, Marcelo Gasca, previously of Caney Creek High School, qualified once again to receive \$1,000 with the 3rd semester of potentially 4 consecutive semesters of the Brooks scholarship.

The **Keaton "KBuss" Bussell Memorial Scholarship Fund** benefits a student at Montgomery High School, who along with academic performance demonstrate leadership, motivation, character, ability, citizenship and potential, in memory of Keaton "KBuss" Bussell. The second scholarship of this fund was \$700, and was awarded to Montgomery High School's Paige Marie Triplett.

The **Shane Dickerson Carter Memorial Scholarship Fund** was created to benefit Montgomery High School seniors who have demonstrated the Rotary International mission of "Service Above Self". This endowed scholarship fund was created by

Rotarian Don Carter in memory of his beloved wife Shane Dickerson Carter. Two \$1,000 scholarships were awarded from this fund in 2020 to Montgomery High School seniors Natalie M. Hasselmeier and Austin Thomas Scott.

The **Mary Jane Hamilton Memorial Scholarship Fund** benefits students from Montgomery County planning to attend Lone Star College-Montgomery. This need-based endowed scholarship fund was created in memory of Mary Jane Hamilton by her loving stepmother, Patti Harrison to honor Mary, an HISD elementary school teacher for 17 years. In 2020, four \$1,000 scholarships were presented to Caney Creek High School Seniors Karla Ramos and Veronica Rodriguez, College Park High School senior Kristienne Tenido, and Willis High School senior Hannah Wilson.

The **Hivnor Family Scholarship Fund** benefits students of Willis High School participating in varsity athletics, including cheerleading and drill team. The commitment of the Hivnor Family emphasizes their strong belief in the importance of higher education. The 2020 scholarship for \$1,000 was awarded to Willis High School senior Carlos Barcenas.

The **Ruben W. Hope, Jr. Memorial Scholarship** was created by the Hope Family and friends to honor Ruben's passion for education and commitment to the people of Montgomery County. The second scholarship for \$500 in memory of Ruben W. Hope, Jr was awarded in 2020 to Conroe High School Senior Elise Marie Ohnheiser.

The **Cort Martin Memorial Scholarship** at Lone Star College-Montgomery was established by combining the Cort Martin Scholarship Fund and the Montgomery College Fund. This need based scholarship is for Conroe ISD seniors planning to attend Lone Star College-Montgomery. It honors the memory of Cort Martin, son of Tim and Deanna Martin, who was tragically killed in an accident. A \$1,100 scholarship was awarded to Ciah E. McCandless, senior from Oak Ridge High School for 2020.

The **Buddy Moorhead Memorial Scholarship** honors the memory of Conroe High School Football Coach Buddy Moorhead. Seniors selected for this award must have participated in football at Conroe High School, have a reasonable chance of success in college, be of good character, and must exemplify the "spirit" of the Conroe Tigers. Christian Pack was the 2020 recipient of this \$700 scholarship.

The **Alfred (Jimmie) and Joyce Soupart Scholarship** is a need-based scholarship for students of Conroe High School. The Souparts believe that higher learning is the pathway to success and have created a legacy of commitment to higher education by providing needed funding. A scholarship of \$3,200 was awarded in 2020 to Conroe High School senior Claudia Garcia.

The **Sowers Family All Means All Graduating Students Scholarship Fund** supports Conroe ISD graduating students who have the drive to continue their education after high school. At least one ninth grade student who will attend Conroe High School will be awarded this incentive 2024 graduation scholarship in the summer of 2020.



The **Texas Osteopathic Rural Initiative (TORI) Fund** will fund over 8 consecutive semesters to Sam Houston State University School of Osteopathic Medicine student(s) who plan to practice rural medicine upon completion of their degree (Scholarships to begin in 2024).

Abandoned Animal Rescue—\$5,000 to provide veterinary care for cats or dogs toward ending pet overpopulation that results in the euthanasia of unwanted cats and dogs.

ACCESS Special Needs Program of The Ark Church—\$10,245 to purchase a rotating adult changing table that assists adults participating in the ACCESS Special Needs program to lie down for changing.

All Ears! Listening & Language Center—\$7,300 to provide Listening and Spoken Language classes for babies and toddlers who are born deaf and their parents.

Angel Reach—\$10,000 to expand the Angel Reach Counseling program services to Angel Reach kinship families caring for children who have been removed from their homes by CPS.

Big Thinkers—\$600 for materials for a 6-week summer tutoring program for underserved elementary school children in Montgomery County who are behind in reading and/or math.



Assistance League of Montgomery County —\$4,800 for new school clothes and literacy under Operation School Bell to help economically disadvantaged youth in all Montgomery County School Districts.

Bridgewood Farms—\$6,800 for exercise equipment, supplies, and coaching for clients that focuses on exercise, nutrition, food, and how it impacts their health.

Community Assistance Center—\$1,300 to improve operational efficiency in the CAC Unique Resale Shop and update safety enhancements to CAC facilities.



Community Christian Legal Aid—\$2,000 to purchase Zoom, high-volume stand-alone scanner, DocuSign, notary license and other technology to enhance ability to work with clients and within the judicial system.

Conroe Noon Lions Club-Charities Fund—\$1,400 for eye-sight conservation projects for the underprivileged.

Conroe Symphony Orchestra —\$4,600 to partially underwrite the June 26, 2021 Patriotic concert.

Coulson Tough PTO—\$600 for essential supplies for the classrooms of new teacher.

Crighton Theatre Foundation— \$2,300 for renovations to Crighton Theatre lobby.

Eagles Nest Ministries of Conroe—\$7,200 to pay for room, clothes, food, counseling services, program curriculum, staff wages and bills to house homeless parolees.

First Baptist Church of Conroe—\$4,800 to distribute to local residents who need assistance with rent, utility and other emergency assistance.

FOB Razor—\$400 to help with rent of expanded space, curriculum purchases and bathroom renovation in mission for veterans, young and old, suffering or not, to receive a buddy check every Friday.

Forever Faithful Ministries—\$5,950 to sponsor horse care for the female residents in Arrow Ministries Freedom's Place who receive Equine Therapy.



God's Garage—\$1,900 to pick up, evaluate, repair, detail, state inspect and gift vehicles to women in order for them to maintain their independence.

Hope's Bridge Resource Center—\$500 to aid in purchase of an enclosed trailer to help move donations, to better serve a larger demographic without limitations of capacity or weather restrictions.



Houston Furniture Bank—\$1,974 provide mattresses to families and children to ensure no child goes without essential sleep and rest for growth and learning.

Inspiration Ranch—\$5,881 two additional certifications for equine specialist to diversify the equine-assisted mental health program.

Kid's Meals—\$4,600 to provide 4,366 meals a month to preschool children in Montgomery County.

Life Giving Life "The Recovery Project"—\$2,042 dedicated to helping our community tackle the substance abuse epidemic that has been rapidly affecting individuals, families, youth and veterans.

Meals on Wheels Montgomery County—\$10,000 purchase stand-alone refrigerated container to increase the amount of food ordered, which will allow expanded services for nutritious meals to homebound seniors.

Montgomery County Food Bank—\$9,600 provides nutritious groceries to support the Food for Senior Adult programs as well as food insecure in Montgomery County.

Montgomery County Women's Center—\$14,500 for urgent and immediate needs.

Montgomery ISD Fine Arts—\$2,900 for programs to enrich the fine arts in Montgomery ISD.

Oscar Johnson Jr. Community Center Volunteers—\$4,800 for after school and summer day camp program support and staff scholarships for higher education.

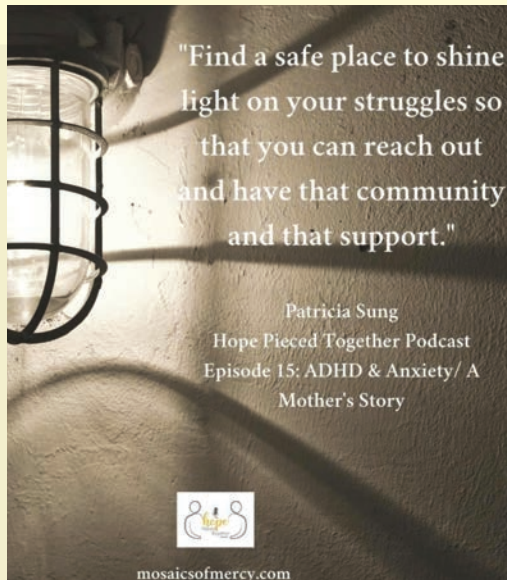
New Caney New Horizons—\$2,658 improvement and continuation of the New Horizons horticulture program enriching the lives of people with intellectual and developmental disabilities.

Rotary Club of Lake Conroe Foundation—\$2,700 funding for maintenance of and planting in Memory Park located adjacent to the Charles B. Stewart West Branch Library, in Montgomery.

Society of Samaritans—\$8,000 to provide material and financial assistance to low, very low, extremely low income families and the homeless.

Special Olympics Texas—\$2,000 support of programs for Special Olympics athletes (individuals with intellectual disabilities) in The Woodlands and Houston, TX. area.

Yes to Youth – Montgomery County Youth Services—\$9,900 to contribute toward the security system and IT infrastructure, furniture, fire alarm monitoring, initial workforce expansion for 2 new residential emergency youth shelter facilities in Conroe.
